What information we collect, use, and why

We collect or use the following information to **provide and improve products and services for clients**:

- Names and contact details
- Addresses
- Occupation
- Financial data (including income and expenditure) for analysis purposes only
- Transaction data (including details about payments to and from you and details of products and services you have purchased) for analysis purposes only
- Records of meetings and decisions
- Website user information

- Additional donor/supporter information not already covered - anonymised - for analysis purposes

We collect or use the following personal information for the **operation of client or customer accounts**:

- Names and contact details
- Addresses
- Account information, including registration details
- Marketing preferences

We collect or use the following personal information for **information updates or marketing purposes**:

- Names and contact details
- Profile information
- Marketing preferences
- Purchase or account history
- Website and app user journey information
- IP addresses

We collect or use the following personal information for **research or archiving purposes**:

- Names and contact details
- Purchase or client account history
- Website and app user journey information
- IP addresses

We collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Account information
- Purchase or service history
- Correspondence

Lawful bases and data protection rights

Under UK data protection law, we must have a “lawful basis” for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO’s website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO’s website:

- **Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for. [You can read more about this right here.](#)
- **Your right to rectification** - You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete. [You can read more about this right here.](#)
- **Your right to erasure** - You have the right to ask us to delete your personal information. [You can read more about this right here.](#)
- **Your right to restriction of processing** - You have the right to ask us to limit how we can use your personal information. [You can read more about this right here.](#)
- **Your right to object to processing** - You have the right to object to the processing of your personal data. [You can read more about this right here.](#)

- Legitimate interests – we’re collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - If someone has indicated they would like to be personally contacted about a service or offer but not "formally" signed up to my mailing list, I will keep a separate record to send a 1:1 communication purely about that offer or service they have indicated an interest in.
 - If someone has purchased downloadable resources or on-demand training I may follow up with you to check the resources have been downloaded effectively or if there is anything else you need for accessibility.
 - If you enroll on my training courses, I will stay in touch with you by email to be able to send course information during the duration of the course.

Where we get personal information from

- Directly from you
- Third parties:
 - Where a client provides their supporters data under a data-sharing agreement for analysis purposes.

How long we keep information

- For the duration of our contract to allow me to complete the work commissioned
- Any supporter data or similar will be deleted as soon as the contract is completed
- Any project-based information will be retained for future reference by the consultant
- Marketing data will be held for the duration of your opt-in. When you opt-out of marketing communications, your data will be archived.

Who we share information with

Others we share personal information with

- Organisations we're legally obliged to share personal information with
- Publicly on our website, social media or other marketing and information media
- Professional consultants where collaboration on a project or contract is applicable

How to complain
